III. Consent Agenda

IV. Reports and Discussion Items

- a) Anne Folkers- Board President
 - (1) Board members discussed their favorite moments of 2021-2022. These included Dan Koenig being voted Administrator of the Year, and many stories of new family's positive impressions of Bergan.
- b) Dan Koenig- Principal, Knightly Tale on Google Drive
 - (1) Senior Class of 2022:
 - (a) the most decorated class in school history,
 - (b) they received over 4.3 million dollars in scholarship offers,
 - (c) this is a group that most of them have been together since elementary school
 - (2) HR update: Haley Kucera will be replaced by Katlin Vampola as a 5/6th grade teacher, and Sue Wewel will be replaced by Deb Erpelding as a middle/high school science teacher
 - (3) Fremont Big Give was May 10. We raised \$49,725, which was 101% of our goal. Funds were collected from 198 donors.
 - (4) The Emergency Assistance to Non Public Schools ROUND 2 (EANS) has allocated \$253,000 for Bergan again this year.
 - (5) The advancement office will be relocating to the parish office.
 - (6) The chapel will be moving downstairs to room 105. This will provide more space. The old chapel space will become a storage room for advancement.
 - (7) The elementary library has new shelves to display more books.
 - (8) The ECEC has new playground equipment.

- (9) We would like to reorganize fundraising efforts as to not exhaust our donors, and to make sure we are using our brand consistently across the board.
- c) Fr. Nolte Parish Pastor/President of school
 - (1) Prepare for a lean year financially, we are going to be leaning on families for help
 - (2) We are working on a 4-6 month facilities report, deciding what we need to plan for.
 - (3) Fr. Mischek will be leaving the end of June. Fr. Tran will be joining us July 1st.
 - (4) We are discussing the possibility of buying the rectory. No decisions have been made yet.
